OI JUN 27 PM 2:52 The undersigned, a natural person competent to contract, does hereby make, subscribe and file the Articles of Incorporation for the purpose of organizing a corporation under the laws of the State of Florida.

ARTICLE I CORPORATE NAME

The name of this Corporation shall be ANDERSON-BAILEY PRODUCTIONS, INC., and its principal office shall be located at 4852 NE 12th Avenue, Fort Lauderdale, Florida, 33334.

ARTICLE II NATURE OF CORPORATE BUSINESS AND POWERS
