ARTICLES OF INCORPORATION OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLEI NAME

The name of the corporation is FOOD SAFETY SOLUTIONS, INC. (hereinafter called the "Corporation").
