Please find the enclosed substitute Annual Report (UBR) for the above shown corporation. I am requesting that you accept this application and payment of \$150.00 to reinstate the corporation for the year 2002.

Mr. Johnny L. Pons, the president of the Corporation, did not receive his initial Uniform Business Report or any subsequent notices for the above shown corporation. It appears that the reports may have wound up in the hands of the former owners of the funeral home purchased by Mr. Pons. When I met with Mr. Pons on October 15, 2002, it was discovered that not only was his corporation administratively dissolved by the State but also that he had failed to complete the proper corporate filings with the Internal Revenue Service.
