The undersigned, as officer of the Corporation authorized to execute this document, hereby certifies as follows:

At a special joint meeting of the Board of Directors and the Shareholders of this Corporation, called and held according to the applicable provisions of the Laws of Florida and this Corporation's Bylaws, on May 1, 2002, at which meeting the sole member of the Board of Directors and a quorum the Shareholders of record were present, and the following Resolutions were adopted by the Board of Directors and the Shareholders of JORU, INC.:

- (1) **RESOLVED**, that the Articles of Incorporation of JORU, INC., be, and they hereby are, amended, to change **ARTICLE THIRD** of the Articles of Incorporation to authorize the issuance of a total of One Million (1,000,000) Shares of Common Stock of the Corporation;
- (2) **FURTHER RESOLVED** that **ARTICLE FOURTH** of the Articles of Incorporation, which presently provides for Shareholder pre-emptive rights, be deleted from the Articles of Incorporation and that the balance of the Articles of the Articles of Incorporation be renumbered upon deletion of **ARTICLE FOURTH**;

The number of votes cast for approval of the Amendment by the Shareholders was sufficient for its approval.
