2. Article IX is amended to read as follows:

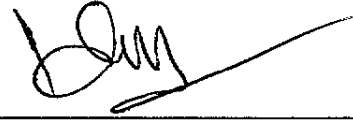
The corporation has appointed the following person(s) as directors of the corporation:
