**ARTICLES OF INCORPORATION
OF**

ARTICLE I

The name of the corporation is KING DAVID 175, INC. (the "Corporation").

ARTICLE II

ARTICLE VI

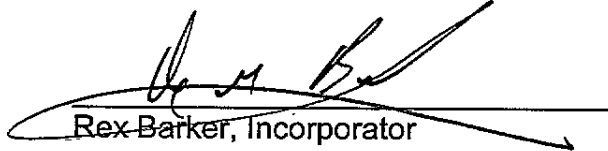

This Corporation shall indemnify and shall advance expenses on behalf of its officers and directors to the fullest extent not prohibited by law in existence either now or hereafter.

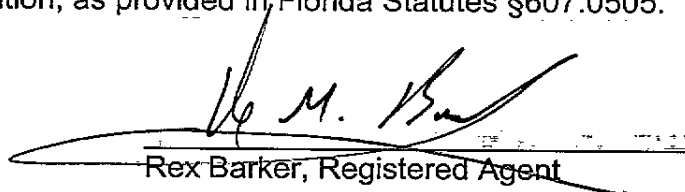
