ARTICLE I

CORPORATION NAME

The name of this corporation is All Access Bobcat Services, Inc.

ARTICLE II

PURPOSE

This corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE III

CAPITAL STOCK

This corporation is authorized to issue 1000 shares of common stock.

The common stock of the Corporation shall have the following characteristics:

- (a) Par value shall be \$1.00 per share
- (b) At all meetings of the stockholders, the common stockholders shall be entitled to cast (1) vote for each share of common stock owned. That a common stockholder is interested in a matter shall not disqualify him from voting thereon.
- (c) Except as otherwise provided by law, the entire voting power for the election of directors and all other purposes shall be vested exclusively in the holders of the outstanding stock.

ARTICLE IV

TERM OF EXISTENCE

This Corporation shall have perpetual existence.

ARTICLE V

The Board of Directors may, from time to time, change the street address of the Corporation as well as the location of its principal office. DATE OF CORPORATE EXISTENCE


The date the beginning of the corporate existence of All Access Bobcat Service, Inc., shall be at the time of subscription and acknowledgment of these articles.


