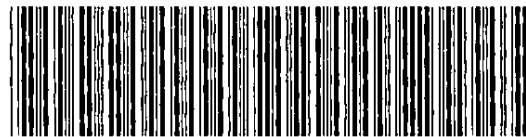

Fehintola Ajayi is *deleted* as Registered Agent of the Corporation.

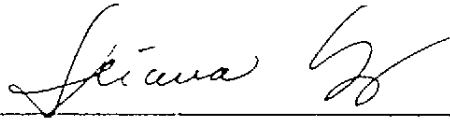
Iliana Gort shall be the new Registered Agent of the corporation at 633 NE 167th Street, Suite 505, North Miami Beach, Florida 33162.

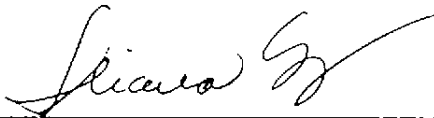
