
ARTICLE X. OPTIONAL PROVISIONS.

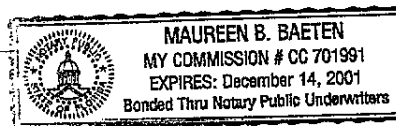
