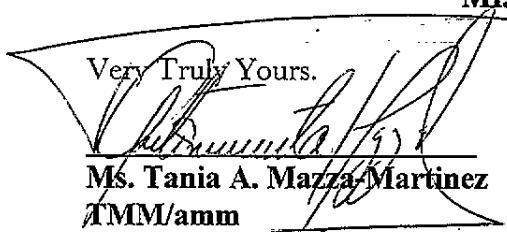

ARTICLE OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is **UTB DESIGNS & PRODUCTION, CORP.**

ARTICLE IX- INDEMNIFICATION

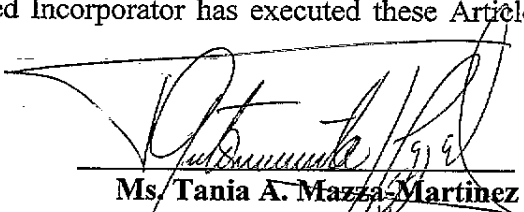
The corporation shall indemnify any officer or Director, or any former Officer or Director, to the full extent permitted by law.

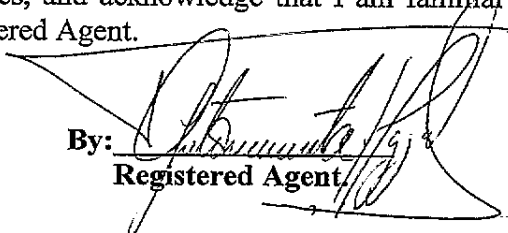
