The corporation's initial Registered Agent and Registered office in the State of Florida are:

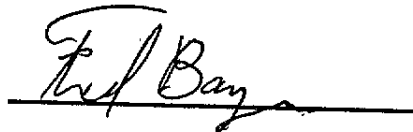

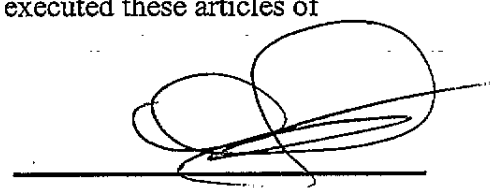
