ARTICLES OF INCORPORATION OF PINEAPPLE PARTNERS, INC.



ARTICLE I - NAME

The name of the corporation is: PINEAPPLE PARTNERS, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 6353 W. Rogers Circle, Suite #1, Boca Raton, Florida 33487

ARTICLE III - DURATION

or in defense of any claim, issue, or mater therein, against all expenses, including attorney's fees,

actually and reasonably incurred by him in connection therewith, without the necessity of an

independent determination that such director, officer, employee, or agent met any appropriate

standard of conduct.

(c) The indemnification provided for herein shall continue as to any person who has ceased

to be a director, officer, employee, or agent, and shall inure to the benefit of the heirs, executors and

administrators of such person.
