Duration

The corporation shall commence as of the date these Articles are filed in the Office of the Florida Secretary of State, and exist perpetually unless sooner dissolved according to law.

Article IX

CAPITAL STOCK

The Corporation shall have authority to issue a maximum of FIFTY-THOUSAND (50,000) shares of voting stock and FIFTY-THOUSAND (50,000) shares of non-voting stock, having no par value.

Article X

BOARD OF DIRECTORS

This corporation initially shall have two (2) directors, which number may be increased or decreased in accordance with the Corporations By-Laws, but shall never be less than one (1).

Article XI

SHAREHOLDERS' RESTRICTIVE AGREEMENT

All of the shares of stock of this Corporation are subject to a Shareholders' Restrictive Agreement containing numerous restrictions on the rights of shareholders of the Corporation and transferability of the shares of stock of the Corporation. A copy of the Shareholders' Restrictive Agreement, is on file at the principal office of the Corporation.

Article XII

INDEMNIFICATION

This Corporation shall, to the fullest extent permitted by the provisions of Florida Statutes Section 607.0850, as the same may be amended and supplemented, indemnify any and all persons whom it shall have the power to indemnify under said provision from and against any and all expenses, liabilities or other matters referred to in or covered by said provisions.

Article XIII

The Corporation shall apply for Subchapter S status under federal law and will not issue or transfer its stock to anyone prohibited by the law from being a Subchapter S stockholder.

Article XIV

BYLAWS

The Bylaws may be adopted, altered, amended or repealed by either the shareholders or the board of directors.
