ARTICLE TWELVE



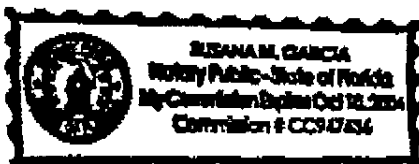
