
ARTICLE VIII



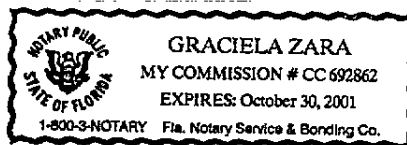
