ARTICLE IV - CAPITAL STOCK

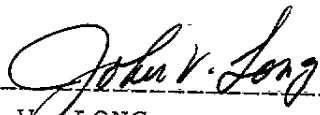
THE CORPORATION IS AUTHORIZED TO ISSUE FIVE HUNDRED (500) SHARES

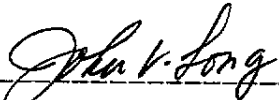
ARTICLE VIII - BY-LAWS
