ARTICLES OF INCORPORATION



The undersigned, hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I - NAME:

The name of the Corporation is THE NETWORK GUY, INC.

ARTICLE II - PRINCIPAL BUSINESS ADDRESS:

The principal place of business and mailing address of the Corporation is 4381 Kimberly Circle, Tallahassee, Florida 32308.

ARTICLE III - COMMENCEMENT AND DURATION:
