The undersigned subscriber to these Articles of Incorporation, natural persons competent to contract, for the purpose of forming a corporation under the Florida General Corporation Act, Florida Statutes Chapter 607, hereby adopts the following Articles of Incorporation:

**ARTICLE I - NAME**

This corporation shall be know as ANTIQUES ON TENTH, INC.

**ARTICLE II - DURATION**

The term of existence of this corporation is perpetual.

**ARTICLE III - PURPOSE**

This corporation may engage in or transact the business of retail sales and all business activities related thereto as well as any and all other lawful business and/or activities for which corporations may be incorporated under the laws of the Unites States of America, The Florida General Corporation Act, the State of Florida and/or any other state, country, territory or nation.

**ARTICLE IV - CAPITAL STOCK**

The aggregate number of shares which this corporation has authority to issue and have outstanding at any time is Ten Thousand (10,000) all of which shall be common shares having a par value of One (\$1.00) Dollar each.

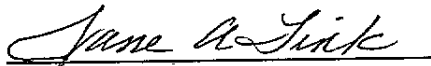
