# Premiere Practice Consultants, Inc.

The undersigned, for the purpose of forming a corporation for profit in the IDA laws of the State of Florida, do hereby adopt the following Articles of Incorporation:

#### ARTICLE I - NAME

The name of this corporation is: Premiere Practice Consultants, Inc.

# ARTICLE II - PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 8118 North University Drive, Tamarac, Florida 33321.

#### **ARTICLE III - DURATION**

This corporation shall exist perpetually. Corporate existence shall commence on the date these Articles of Incorporation are filed by the Secretary of State.

## **ARTICLE IV - PURPOSE**

# ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The Board of Directors may from time to time move the office to any other address in Florida and/or designate another individual to serve as the Registered Agent of this corporation.

# ARTICLE VII - INITIAL OFFICERS AND BOARD OF DIRECTORS

This corporation shall have three (3) officers and directors initially. The number of officers and directors may either be increased or decreased from time to time by an amendment of the By-Laws of the corporation, in a manner provided by law, but shall never be less than one (1).
