The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida STATE TALLAHASSEE FLORIDA

### ARTICLE I CORPORATE NAME

The name of the Corporation is CONSOFT TECHNOLOGIES U.S., INC. and the initial address of this corporation shall be 4200 N.W. 3<sup>RD</sup> Ct # 132, Plantation, Florida 33317.

#### ARTICLE II PURPOSE

The purpose of the Corporation is to engage in any lawful act or activity for which a corporation may be organized under the Law of the United States of America and the State of Florida other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the State of Florida Corporations Code.

### ARTICLE III REGISTERED OFFICE/AGENT
