## ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby present these Articles for the formation of a corporation for profit under Florida Law.

#### ARTICLE I - NAME

The name of the business corporation is JOANNA'S DESIGNS, INC.

#### ARTICLE II - PURPOSE

The general nature of the business to be transacted and the purposes for which the business corporation is organized are:

- A. To engage in any activity or business permitted under the laws of the United States and of the State of Florida.

#### **ARTICLE IX - VOTING TRUSTS**

No stockholder of the corporation shall enter into a voting trust agreement or any other type of agreement vesting in another person the authority to exercise the voting power of any or all of his shares.

#### ARTICLE X - VOTING FOR DIRECTORS

The Board of Directors shall be elected by the stockholders of the corporation at such times and in such manner as provided by the By-Laws of the corporation.

## ARTICLE XI - RESTRAINT ON ALIENATION OF SHARES

The stockholders of the corporation shall have the power to include in the By-Laws, adopted by a majority of the stockholders of the corporation, any regulatory or restrictive provisions regarding the proposed sale, transfer or other disposition of any of the outstanding stock of the corporation by any of its stockholders, or in the event of the death of any of its stockholders. The manner and form, as well as the relevant terms, conditions and details thereof, shall be determined by the stockholders of the corporation; provided, however, that such regulatory or restrictive provisions shall not affect the rights of third parties without the actual notice thereof, unless the existence of such provisions be plainly written upon the certificate evidencing the ownership of such stock. No stockholder of the corporation may sell or transfer his stock therein except to another individual who is eligible to be a stockholder of the corporation, and such sale or transfer may be made only after the same shall have been approved at a stockholders' meeting, specially called for such purpose. If any stockholder becomes legally disqualified to be a stockholder of the corporation, such stockholder's shares of stock shall immediately become subject to

purchase by the corporation in accordance with the By-laws adopted by the stockholders.

#### ARTICLE XII - INDEMNIFICATION

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

#### **ARTICLE XIII - BY-LAWS**
