

**ARTICLE I - NAME**

The name of this corporation is J.W. Concrete Pumping, Inc. The principal place of business shall be at 6501 Lake Avenue, West Palm Beach, FL 33405.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

**ARTICLE III - PURPOSE**

The purpose of this corporation is to engage in any activities or business permitted under the laws of the United States and Florida.

**ARTICLE IV - CAPITAL STOCK**

The maximum number of shares that this corporation is authorized to have outstanding at any time is 100 shares of common stock having a par value of Ten Dollars (\$10.00) per share.

**ARTICLE V - INITIAL REGISTERED AGENT AND OFFICE**


#### ARTICLE VIII - INDEMNIFICATION


