ARTICLES OF INCORPORATION OF H.H.E.R.S., INC.

The undersigned subscribed to these Articles of Incorporation to form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this Corporation is:

H.H.E.R.S., INC.

and its initial office address and its principal office for the conduct of business is:

3315 DeLeon Street, Suite 12 Tampa, Florida 33609

The Board of Directors may from time to time move the principal office to any other address in Florida.

ARTICLE II

The general nature of the business to be transacted by this corporation is:

- a) To engage in every aspect and phase of profitable business, especially to provide personnel recruiting services. To invest the funds of the corporation in real estate, mortgages, stocks, bonds, or any other type of investment and to own real estate and personal property necessary for the rendering of professional services.
- b) To do all and everything necessary and proper for the accomplishment of any of the purposes or the attainment of any of the objects or the furtherance of any of the purposes enumerated

in these Articles of Incorporation, or any amendment thereof, necessary or incidental to the protection and benefit of the corporation, and in general, either alone or in association with other corporations, firms, or individuals, to carry on the lawful pursuit necessary or incidental to the accomplishment of the purposes or the attainment of the objects or the furtherance of such purposes or objects of this corporation to such extent as a corporation organized under the <u>Florida Statutes</u> may now or hereafter lawfully do.
