The name of this corporation shall be called LinVin Enterprises, Inc.

ARTICLE II

The corporation's principal place of business shall be 228B Foxtail Drive, West Palm Beach, Fl. 33415.

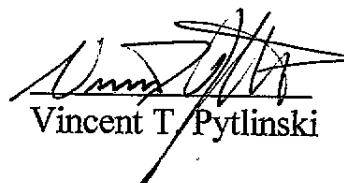

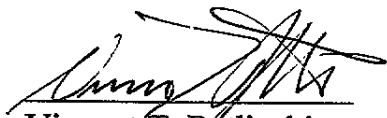
