ARTICLES OF INCORPORATION

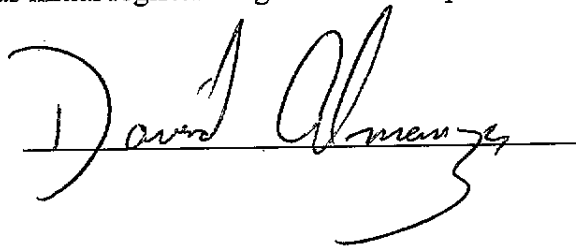
