ARTICLE I. - CORPORATE NAME

The name of this corporation is Lorven, Inc.

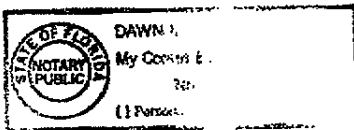

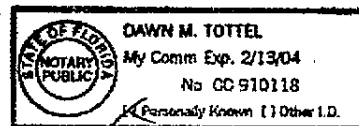


