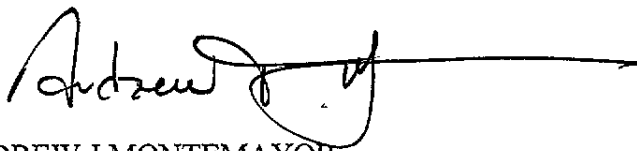

ARTICLE SEVEN

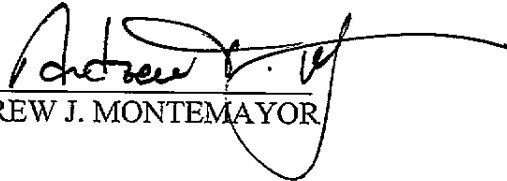
