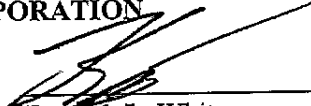

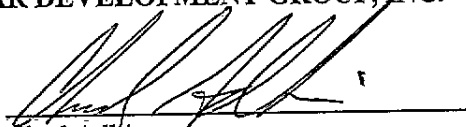

The following Plan of Merger is submitted in compliance with Section 607.1101, *Florida Statutes*, and in accordance with the laws of any other applicable jurisdiction of incorporation.

1. The name and jurisdiction of the surviving corporation:

ALSTAR DEVELOPMENT GROUP, INC. **Florida**

2. The name and jurisdiction of the merging corporation:
