The undersigned natural persons, at least 18 years of age, for the purposes of forming a corporation for profit pursuant to the provisions of Chapter 607 Florida Statutes, do hereby certify the following:

ARTICLE I – NAME

The name of the corporation shall be CUSTOM CONCRETE EDGING, INC.

ARTICLE II – DURATION

The corporation shall exist perpetually commencing on the 25th day of June, 2001.

ARTICLE III – PURPOSE

The purpose for which the corporation is organized is instillation of concrete edging and transacting any other lawful business.

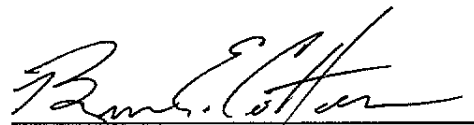

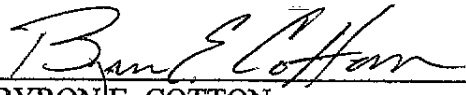
