First: The name of the Corporation is SUNMED FINANCIAL SERVICES, INC.

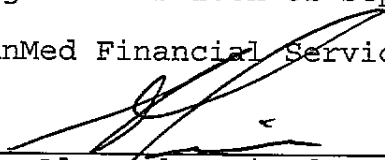

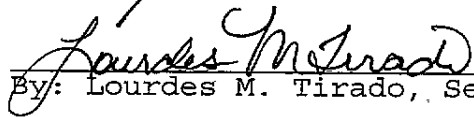

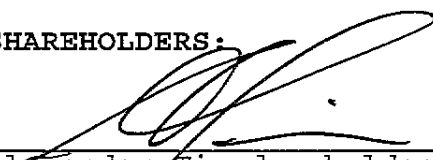

Resolved, that Article 1 of the Corporation's Articles of Incorporation is hereby amended to read as follows:

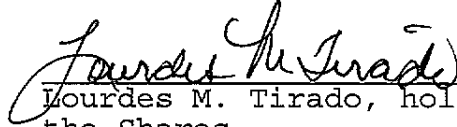
