ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this Corporation is NEW AGE SERVICES & CONSULTANTS, INC.

ARTICLE II - DURATION



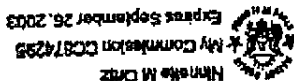
