
**ARTICLE IX – BYLAWS**

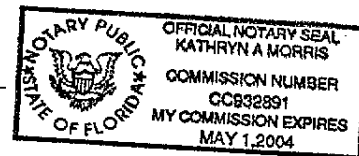
