The undersigned, for the purpose of forming a corporation under the provisions of Chapter 607, Florida Statutes, (FLORIDA BUSINESS CORPORATION ACT"), hereby adopts the following Articles of Incorporation:

ARTICLE I

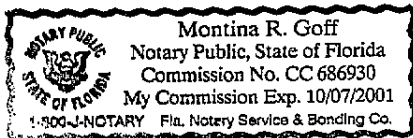
