

## ARTICLES OF INCORPORATION OF GATEWAY PROPERTY DEVELOPMENT, INC. ARTICLES OF INCORPORATION OF GATEWAY PROPERTY DEVELOPMENT, INC.

SECRETARY OF STATE TALLAHASSEE, FLORIDA

The undersigned, for the purpose of forming a corporation under the Florida business Corporation Act, do hereby adopt the following Articles of Incorporation:

#### ARTICLE I NAME AND ADDRESS

The name of the corporation is Gateway Property Development, Inc.. The principle office of the corporation is 1104 E. Seventh Avenue, Tallahassee, FL 32303. The mailing address of the corporation is P.O. Box 1026, Tallahassee, FL 32302.

ARTICLE II DURATION

The duration of the corporation is perpetual.

### ARTICLE III PURPOSE

The general purposes for which the corporation is organized are the following:

- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
- B. To do such other things as are incidental to the purposes of the corporation or necessary or desirable in order to accomplish them.

## ARTICLE IV SHARES

The aggregate number of shares which the corporation is authorized to issue is One Hundred (100) shares of common stock. Such shares shall be of a single class and shall have a par value of One (\$1.00) Dollar per share.

## ARTICLE V INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 1104 E. Seventh Avenue, Tallahassee, FL 32303, and the name of its initial Registered Agent at that address is Matthew Parker.

#### ARTICLE VI INITIAL BOARD OF DIRECTORS
