ARTICLES OF INCORPORATION

of

ARTICLE I

The name of this corporation shall be Michelle Vybinovsky, Inc.

ARTICLE II

The principal office and mailing address of this corporation shall be 12907 Pepper Pl., Tampa, FL 33624.

ARTICLE III

This corporation is formed for the purpose of conducting any business or business transaction lawfully permitted by the Florida Business Corporation Act.



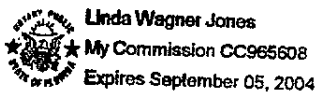

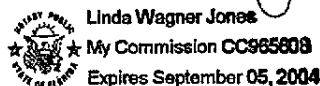
