I. NAME

The name of the corporation is HLOIDAY RENTAL COMPANY, INC.

II. TERM OF EXISTENCE

X. AMENDMENTS

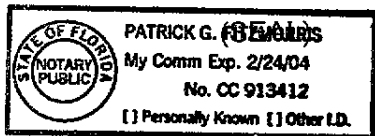


