ARTICLES OF INCORPORATION OF SOLAR BLOC PRODUCTS, INC.

ARTICLE I - NAME

The name of this corporation is Solar Bloc Products, Inc., 1216 Heritage Acres Boulevard, Rockledge, Florida 32955.

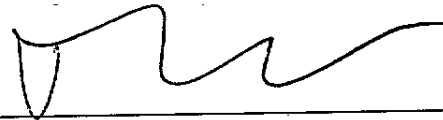
