The postcard titled "NOTICE OF INTENT TO DISSOLVE" is the first correspondence we received from your office this year. We were expecting an envelope, like we received the previous year, with our information to renew and our annual report. We received neither that nor a postcard.

We are a new corporation and this is only our second renewal, thus the May 1st deadline was not a red flag to us without receiving information or forms. I can ensure your office that this will no longer be the case.

In addition, once we received your postcard titled "NOTICE OF INTENT TO DISSOLVE", went to the website requested and submitted my document number listed above, my corporate information would appear, the document would appear to download, but would appear blank. We tried this on 4 different computers all on dial-up with 2 different internet provider programs, 2 different operating systems, and even downloaded an entirely new version of Adobe Acrobat. Nothing worked.

My husband (a CNE), and another CNE from a major corporation each tried on dial-up and on DSL and T-1. This was to no avail. My husband wrote to the webmaster to report the problem and received no cooperation. Finally, I drove 20 miles to my accountant's office yesterday and she was able to download the form on her computer. I had tried 1-hour-earlier-on-mine, and again could not see it.

Under the circumstances of not receiving the paperwork from Tallahassee to file on time, we are enclosing a check for \$150.00. We feel a \$400 penalty would be unfair and We respectfully request that you abate all penalties.. We appreciate your cooperation and understanding in this matter.
