**ARTICLES OF INCORPORATION
OF
DOMINY AUTO TRANSPORT, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I-NAME

The name of this Corporation is Dominy Auto Transport, Inc.

The name and street address of the incorporator is Jerry Lee Dominy, 4090 Hodges Blvd., #703, Jacksonville, Florida 32202.


ARTICLE VII-BYLAWS
