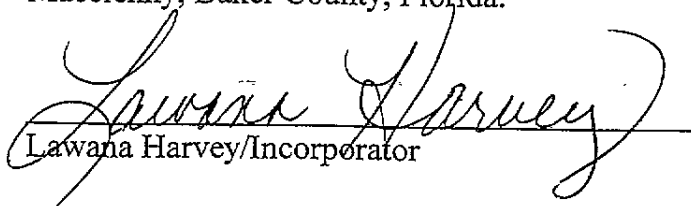
#### **ARTICLE IX. PREEMPTIVE RIGHTS**

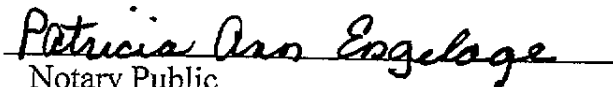

#### **ARTICLE XI. AMENDMENT TO ARTICLES**

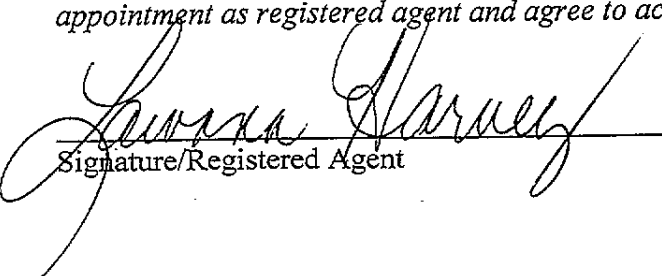
