#### ARTICLES OF INCORPORATION

OF

#### CCOMSTAT CORPORATION

#### ARTICLE I - NAME

The name of the corporation is CCOMSTAT CORPORATION.

### ARTICLE II - DURATION

This corporation shall have perpetual existence, unless sooner dissolved according to law.

### ARTICLE III - PURPOSE
