ARTICLES OF INCORPORATION  
FOR

**ARTICLE I**

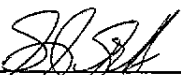
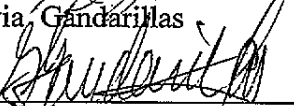
