5. A majority of the incorporators has authorized the dissolution of the Corporation.

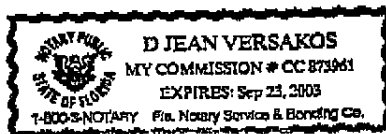


