To Whom it May Concern:

After contacting the Department of State, Division of Corporation, I was advised to write this letter to explain a problem that I had in filing one (1) of the two (2) Uniform Business Reports that I am required to file each year. Unfortunately, I believe that one of the reports has not been received by you as one of the checks has never been processed. My situation is as follows:

On March 21, 2002, I sent in two (2) separate Uniform Business Reports with two (2) separate checks from two (2) different bank accounts for two (2) different Florida Corporations in two (2) different envelopes.

1) Gulf Coast Counseling Inc. (Tax Id: 65-0672652) was paid with Southtrust Bank check # 1732 and that check has been cashed.

Unfortunately, on May 5, 2003, my accountant asked about a check # 1171 drawn on Peninsula Bank written on March 21, 2003 that had not cleared the bank. Upon review of our bank account, I found that the check was for the Uniform Business Report for Sarasota Counseling and Psychiatric Services Inc. (Tax Id: 65-1118605) My Accountant advised me of the penalties for filing late after May 1st and to call the Department of State, Division of Corporation to inquire of a remedy and to file the proper forms.

The Department of State, Division of Corporation advised me to re-file the Uniform Business Report, send another check for \$150 along with this letter explaining our situation and to ask for a <u>waiver on the penalty for filing after the May 1st deadline</u>. As you can see, there is evidence that we did send our other Uniform Business Form in a timely manner and we would hope that someone there could make the decision to generously waive the penalty and to reinstate our corporation as if the initial Uniform Business Report was received as intended on time.
