The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following articles of incorporation.

ARTICLE ONE NAME

The name of the corporation is Blue Wave, Inc.

The duration of the corporation is perpetual.

ARTICLE FOUR PURPOSE OF PURPOSES

The general purposes for which the corporation is organized are:

- 1. To engage in the business of instructing and promoting the sport of surfing.
- 2. To engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the preceding business.
