I. NAME OF CORPORATION

The name of the corporation is Racing Print Media, Inc.

II. PURPOSE

The purpose of the corporation is to engage in the lawful activity of printing and marketing along with any lawful act or activity for which a corporation may be organized under the Corporation Law of Florida other than the banking business, the trust company business, or similar prohibitions under the corporation law of the State of Florida.

III. AGENT FOR SERVICE OF PROCESS

IV. STOCK

The corporation is authorized to issue only one class of shares, which shall be designated "common shares," having a total number of One-Thousand (1000) shares. The stock shall be issued at par value. After the subscription price has been paid, the stock shall not be subject to assessment. The holders of the Common Stock shall have unlimited voting rights and upon dissolution will receive the net assets of the corporation.

V. NUMBER OF SHAREHOLDERS

The corporation's issued shares shall be held of record by not more than three persons.

VI. NO PREFERENCES, PRIVILEGES, RESTRICTIONS

No distinction shall exist between the shares of the corporation or the holders thereof.

VII. GOVERNING BOARD

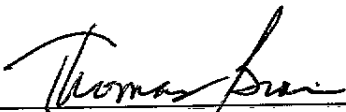
