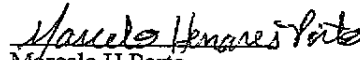
ARTICLE VII AMENDMENTS

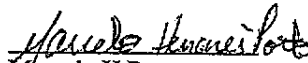

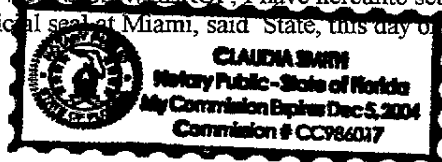
