ARTICLES OF INCORPORATION

MAJID KHAN and JAMIL KHAN, the undersigned, hereby make, subscribe, acknowledge and file these Articles for the purpose of forming a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be KHAN BROS., INC.

ARTICLE II - PURPOSE

This corporation is organized for the purpose of owning and/or operating a convenience store and deli and transacting any and all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or may after be amended.

ARTICLE III - CAPITAL STOCK
