**ARTICLE I - NAME**


## **ARTICLE XI - AMENDMENTS**

**ARTICLE XII - PRE-INCORPORATION AGREEMENT**



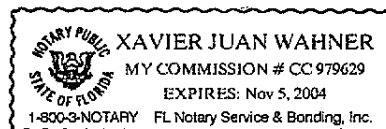
