I would like to take a moment to explain the circumstances, why the Uniform Business Report (UBR) was not filed or paid in a timely manner.

The Uniform Business Report was never received. The registered agent did not forward nor inform me of this responsibility. I had not dealt with the attorney for over a year. It was either obtained or inadvertently never mailed, was lost in the mail, or was never received. None of the parties involved were aware there was a problem until the company received notice in August 2003 that it will cost \$550.00.

Immediately upon notification the UBR was sent in to the State of Florida with a fee of \$150.00 for the year 2003. .

Based on the above facts, we respectfully request that the Department of State waive the penalties that have been assessed. There has been no effort by any of the concerned parties to either avoid filing the UBR form or paying the requisite fees involved.
